MATTE ADD may be stirred into standard acrylic sealers to turn any acrylic sealer into a low gloss coating. Unlike many silica additives, Increte **MATTE ADD** will stay suspended in solution longer, without continuous stirring.

DIRECTIONS FOR USE

APPLICATION PROCESS

MATTE ADD can be used in most acrylic sealers and coatings where lower gloss is desired. MATTE ADD can be used indoors or outdoors, especially over decorative concrete surfaces.

Standard Dosage – 8 fl.oz per gallon, or 1 pound per 5 gallon pail. Dosage may be varied to achieve the desired effect. Dosages above 12 fl.oz per gallon may cause excessive viscosity build. Performance and results will vary based on sealer choice and application conditions. Perform jobsite tests for optimum results.

Procedure – Apply first coat of sealer without the addition of MATTE ADD.

Mix sealer or coating to proper consistency. For best results, pull off 20-30% of the material and slowly add prescribed amount of **MATTE ADD** while mechanically mixing and mix until properly dispersed. Then return flattened material to container and re-mix.

Once first coat of sealer has dried, apply flattened sealer in an inconspicuous area and allow to dry to verify desired effect.

Apply in thin, uniform coats. If material is allowed to sit, re-mix before use.

Results may vary depending on coating, substrate and application techniques.
